
Organization Registration Process



# Tournament Team Affidavit Application

Complete the Tournament Team Affidavit Application. The form is emailed to each organization upon league registration.

- 1. Enter the # of Teams you will register in each division for National Play.
- The Total Amount Due will be automatically calculated based on the # of teams registered.
- 3. Mail completed form and payment to the appropriate Division Director as indicated on the application.



- This is an ONLINE system (https://pony-affidavit.org) that will require the following information
  - League and League Contact Information
  - Affinity Membership ID (This is your league ID sent to you when you registered
  - Manager/Coach Information
  - Player Information
  - Parent Information
- League registration into the system is required
- President or representative will create team shells (blank affidavits) for All Star Tournament Teams
- Manager will build their team Affidavit
  - Manager/coach/player/parent information

Click here to login as a team and complete the affidavit. Please contact your league official if you have not received your login information.




\*\* If your league has previously created a login for the Affidavit System you will not need to create a new login. Please obtain the login information from the previous League Rep who registered your Tournament Teams for the previous season and SKIP TO SLIDE 11. \*\*

- Step 1
  - League president REGISTERS his/her league in the Affidavit system (if not done previously)
- Step 2
  - League president CREATES a shell (blank affidavit) for each All Star Tournament Team
- Step 3
  - Manager acknowledges administrative requirements
  - Manager builds the affidavit
    - Manager, Coach, Business Manager, Player and Parent information

Printing of the affidavit and obtaining signatures remains as in the past with the addition of parent/guardian is now required to sign the affidavit acknowledging the medical release statement on the affidavit






League Insurance and League Officer Information is required to proceed.

CLICK "New Request Group" - This will create a new Affidavit ID number (League Specific)




CLICK "Add Team"




Add Teams Individually

The next step will be for Team Manager/rep to enter team details:


- Manager and Coach information

- Enter Parent information

Once all team details have been accurately entered, CLICK "Submit Affidavit".

Manager should Print / Email Affidavit and have it signed by President/League Rep.

Once Affidavit has been submitted three documents will be available and should be carried in the Tournament Team Binder, checked in and signed by Tournament Director for each level of play.

- 1. Tournament Team Eligibility Affidavit (Signed by League Officer)
- 2. Medical Release (Signed by Parents/Legal Guardians)
- 3. Tournament Pitching Record (Completed by Tournament Director)

- Pitching Record (Kid Pitch Divisions)
- Proof of Identification for each player (Birth Certificate, Passport, ID)
- Individual Photo of each player
